What is the GDPR?

The EU General Data Protection Regulation is a new regulation that is intended to strengthen and unify data protection, across the 28 EU member states, protecting sensitive personal information from being lost, stolen or shared.

From 2018 it will be a crime to lose unprotected data.

Complete implementation and strict enforcement of the EU GDPR.



Penalties

This is what you will be fined unless you protect your data

4% of annual global turnover (NB turnover, not profit)
or

€20 million – whichever is greater.

1. Be aware of the new regulation and what it means to your company.



2. Define your strategy for protecting your sensitive data.



3. Ensure your staff are trained/aware of the GDPR.

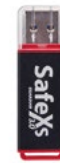
